### PROCLAMATION 2018 - 14

#### RECOGNIZING 2018 AS YEAR OF THE BIRD IN BERLIN

WHEREAS, Birds are present in every environment urban or rural, wetland or forest and are an ever-present reminder that nature is all around us; and

WHEREAS, Each season, the Berlin area is home to one of North America's largest migrations when we host thousands of songbirds, raptors, and waterfowl throughout the region, which is part of the Atlantic flyway; and

WHEREAS, From Berlin's town parks to the majestic stands of Bald Cypress to our south and the Atlantic barrier islands on the east and every area in between, Berlin's rich natural resources support more than 200 bird species; and

WHEREAS Berlin's residents and visitors significantly contribute to the \$41 billion that Americans spend annually on birding trips and equipment, and actively participate in important censuses such as the Annual Christmas Bird Count and the MD/DC Breeding Bird Atlas Project; and

WHEREAS Habitat loss and climate change are major threats to birds; and

WHEREAS 2018 is the centennial year of the Migratory Bird Treaty Act which protects birds in our backyards like the Northern Cardinal and the Blue Jay; and

WHEREAS Osprey, Great Egrets and Wood Ducks nest and migrate through the Berlin area; and

THEREFORE, I, WM, GEE WILLIAMS, III, Mayor of the town of Berlin, do hereby proclaim 2018 the Year of the Bird and urge all citizens to take due note of the observance.
